August 8, 2023 - 9:00 am

Executive Session

Mr. Davis was excused and an Executive Session began at 9:16 for 15 minutes to discuss pending litigation with our attorney per RCW 42.30.110 subsection (1)(i) and all appropriate subsections in the RCW. The original session ended at 9:31, but a 5-minute extension was announced to the public and officially ended at 9:36am. It was decided by the Commissioners to give C. Faix the authority to present a counter offer to the Attorney at CSD which will be passed onto the complainant.

The FMLIVE is now live and CenturyLink has been cancelled.

There was almost 7000 gallons of fuel delivered on 8/7.

G. Weaver made a motion to raise the fuel price to \$6.899 per gallon. K. Schutte second, motion passed.

M. Connor brought in the sublease for the Commissioners to review. The word "Primary" will be removed from the phrase primary residence, making sure the building will not be lived in. The Port will also be named in Article 6 about prior authorization on any improvements. C. Faix will discuss the sublease further with M. Conner.

The current return of investment is on the County Investment Account is 5.199%.
